Halifax Vogel Group Pty Ltd, ABN 75 104 808 853, guarantees the clear & tint PVC marketed as 'easislip™', will not degrade or show serious evidence of material breakdown as a result of exposure to Ultra Violet light under normal operating conditions for a period of three years from the original date of purchase.

Halifax Vogel Group Pty Ltd further warrants easislip PVC meets all published factory specifications, as per the easislip data sheet, at the time of manufacture.

No warranty applies where damage is as a result of scratching, maintenance, cleaning or abuse. Damage caused by installation, alterations, mishandling or excessive loading. Further the warranty is void where a regular cleaning program is not maintained as per the recommendations detailed in the specific cleaning document "Easislip cleaning instructions for Japanese calendered PVC". Claims for replacement or part cost of the product, will be considered if the following is adhered to by the claimant:

- Documentary proof of purchase date, original purchaser and price, is provided.
- Samples/Photos or Proof of the 'damaged' product are provided.
- Access is given to Halifax Vogel Group Pty Ltd staff to inspect the 'damaged' product on site.
- The claimant inspected the product for possible flaws before installation of the product.
